#### RECITALS

UPON hearing Counsel for the Claimants and no one attending or being represented on behalf of the named defendants

AND UPON the Curt having granted an injunction on 5 October 2022 ("the Injunction")

AND UPON the Court having read the Fourth Witness Statement of Keith Spencer dated 15 November 2022

AND UPON the Court noting that pursuant to CPR 6.14, the First Defendant, the Third Defendant and the Fourth Defendant ("the Named Defendants") are deemed to have been served with the claim on 14 November 2022, the Claim Form having been left at their respective residences on 10 November 2022.

## IT IS ORDERED THAT:

- (1) The actions taken by the Claimants' agents on 10 November 2022 (as set out in the witness statement of Mr Spencer dated 15 November 2022), are deemed to be good service of the Injunction on each of the Named Defendants and the requirement for personal service is dispensed with.
- (2) The Claimants shall post a copy of this order on the Service Website (referred to in paragraph 9 of the Injunction) as soon as reasonably practicable after a sealed version of it is received.
- (3) The Claimants shall serve a copy of this order by post on the Named Defendants as soon as reasonably practicable after a sealed version of it is received.
- (4) The Claimants' solicitors shall write to the Court by 4pm on 19<sup>th</sup> December 2022 confirming:
  - a. Whether they have received any response to the claim from any defendants.
  - b. In the event that any defendant has responded to the claim, whether a case management hearing or any directions are required before disposal of the claim.
  - c. The time estimate for a final disposal hearing (to determine the claim and decide whether a final injunction ought to be made).
  - d. Any dates to avoid for listing of the final disposal hearing (or a case management hearing if any defendant has responded to the claim) within a window between 1 March 2023 and 1 June 2023.
- (5) Costs of the application be in the case.
