ORDER	

UPON hearing Counsel for the Claimants and no one attending or being represented on behalf of the named defendants

AND UPON the court having granted an interim injunction on 5 October 2022 ("the Order")

AND UPON it becoming apparent that the court had not issued the claim

AND UPON the Claimants not yet having sealed claim documents but having posted unsealed versions of those documents on a Service Website

AND UPON the Claimants having taken steps to give notice of the injunction to the named defendants, but not yet being able to effect service of the claim without having sealed claim documents

AND UPON it being necessary to consider service of the injunction and claim on the named defendants at a further hearing

IT IS ORDERED THAT:

- (1) The actions taken by the Claimants (as set out in the Third Witness Statement of Mr Waite dated 17 October 2022 and the Third Witness Statement of Mr Spencer dated 18 October 2022) to post notice of the claim are deemed to comply with paragraphs 10-12 of the Order.
- (2) The Claimants shall serve the Claim Form and Particulars of Claim on the named defendants as soon as reasonably practicable after sealed claims documents are received.
- (3) The Claimants shall update the Service Website (referred to in paragraph 9 of the order of 5 October 2022) and any other copies of the claim documents with the sealed versions as soon as reasonably practicable after the sealed claim documents are received.
- (4) The Claimants shall post a copy of this order on the Service Website (referred to in paragraph 9 of the Order) as soon as reasonably practicable after a sealed version of it is received.
- (5) The matter be re-listed for a further hearing on 16 November 2022 with a time estimate of 1 hour.
- (6) Costs reserved.
